- **Unrestricted funds:** create a living impact that will grow and change with the community by directing dollars toward the most pressing needs.
- **Designated funds:** specify a particular charitable agency or organization to receive the proceeds.
- **Donor-advised funds:** allows donors to suggest which organizations or projects are to be impacted.
- **Field-of-interest funds:** allows donors a chance to impact an area of interest that's important to them, such as the arts, education, agriculture, youth, or seniors.
- **Scholarship funds:** enables donors to impact the higher-education needs of area students.
- **Establishing a fund:** is easy and your gift supports the long-term vitality of our Clark County communities. With this fund you may create a lasting legacy of your own choosing!
