**1.** Meeting was called to order at 7:50 pm by President Steve Hemersbach.

- **2.** Steve Hemersbach, on behalf of the Board of Directors, welcomed everyone present. Introduction were made of the invited guests, committee members, spouses of Directors and others present. Parkway Pines restaurant was thanked for the evening's wonderful meal and everyone present expressed their appreciation to the staff for their efforts.
- **3.** Secretary's Report Minutes of the 2015 Annual Meeting were presented and reviewed by Secretary Carrie Morrell. Motion to accept the minutes as presented was made by Sheila Nyberg and seconded by James Schmidt. Voice vote taken, all Aye, motion carried.
- **4.** President's Report Steve Hemersbach presented his report of the Clark County Community Foundation's 2015 activities and referred everyone to *2015 Annual Report* provided for their review. Hemersbach also discussed the history of community foundations and their impact on society. He noted that one hundred years ago, in 1916, the first community foundation was established in Cleveland, Ohio; today there are over 800 community foundations in the United States with over 48 billion dollars in assets, that have distributed millions of dollars in scholarships and grants back to communities.
- 5. Treasurer's Report Natalie Erpenbach presented and reviewed the 2015 financial report (see *2015 Annual Report*). The establishment of the 1897 Clark County Jail Museum Endowed Agency Fund was discussed, including the story of Bernadine Peterson and her gift made in honor of the late Francis Steiner. Erpenbach also discussed the Foundation's goal to become a certified community foundation in the future. Bruce Westphal made a motion to accept financial report as presented, subject to audit if and when appropriate, seconded by Judy Smriga. Voice vote taken, all Aye, motion carried.
- **6.** Review and Adoption of Revised Bylaws President Hemersbach presented the proposed changes to the Foundation Bylaws (Article V, Section 5.05) which had been previously discussed and accepted at previous Board of Director meeting. Discussion followed with questions asked and answered. Motion made by Don Pentz to approve the bylaw changes as presented, seconded by Sheila Nyberg. Voice vote taken, all Aye; motion carried.
- **7.** Recognition of Retiring Directors Retiring Directors (Judy Smriga and Denise Erpenbach) were recognized for their contribution to the Foundation.

- 8. Election of Directors & Officers Nominating Committee chairperson James Schmidt reported that the following directors whose term of office was expiring, had each been contacted and agreed to be nominated for a three-year term of office to succeed themselves on the Foundation's Board of Directors. The Committee nominates Carrie Morrell, Natalie Erpenbach, and James Schmidt for a term of office from April 2016 to April 2019. A request for additional nominations was made by Hemersbach (three times); no additional nominations were made. A motion was made by Sheila Nyberg to suspend the rules of order and cast a unanimous ballot for those so nominated. Anne Teska seconded the motion, voice vote taken, all Aye, motion carried.
- **9.** Old Business None
- **10.** New Business Sheila Nyberg discussed the continuing efforts of the Development Committee and Board of Directors to promote and encourage participation in the *Charter Donor Society* and other Foundation Funds.
  - Hemersbach held drawing to determine recipients of the beautiful tabletop floral arrangements.
- **11.** Adjourn Meeting Motion made by James Schmidt to adjourn the 2016 Annual Meeting at 8:36 p.m., seconded by Don Pentz. Voice vote taken, all Aye, motion carried. Meeting adjourned.

#### 4. President's Report and Annual Message

In anticipation of writing this message, perhaps for my own inspiration, I visited the websites of various community foundations throughout the United States. A website of an established foundation in North Carolina had some memorable observations, quotes if you will, from some (of their) benefactors that I want to share...

- "A hundred years from now it will not matter what my bank account was, the sort of house I lived in or what kind of car I drove... but the world may be different because I was important in the life of a child";
- "You can't have significance in life if it is all about you, you find joy in your life through service and sacrifice"; and
- "Being of service is not an option, it is a biological necessity. Every kind of action we do for someone is a reanimation of our own life's force and of the other person."

Wise words, and well spoken.



## The best time to plant a tree...

I often remind myself, and others, of the success our neighboring community foundations have experienced since their organization(s) back in the 1990s. Because of their efforts and the generosity of their Donors, the "seeds" they planted years ago, have grown and now bear the fruit of that labor. These Foundations, who once administered assets in the thousands / hundreds of thousands of dollars, now, each have assets valued in the millions.

Perhaps our efforts here at the Clark County
Community Foundation can best be put into
perspective by invoking a Chinese Proverb that
observes, "The best time to plant a tree was twenty
years ago, the second-best time is now". Indeed, it
is "now" we are focused on. We can rightfully
laud the progress we have made to date.
Remember, it was only a few short years ago, that
the idea of a community foundation in Clark
County was first discussed and acted upon.

Now, because of the commitment of people who believe in the merits of a community foundation and the many hours of effort they have given, we find ourselves running on two parallel tracks. On one, we continue the work of formalizing our policies and procedures which allow us to operate in a consistent and professional manner. These efforts also help move us closer to becoming an accredited *Certified Community Foundation* which we hope to apply for within the next few years.

The second track on which we travel – includes all the reasons and purpose for which the Foundation was created. We solicit contributions from generous donors, invest and manage these gifts with help from financial advisors, and then distribute financial support in the form of scholarships to students and grants to area charitable programs. Even with our limited resources, we are thankful and excited to be in the third year of our Scholarship Program and will shortly begin work on the Foundation's second Grant Allocation cycle.

## Bringing it all together

We look forward to a time when these two "tracks" merge into one and we can focus on the Clark County Community Foundation's Statement of Purpose which says in part:

"... for the broad-based charitable benefit of the communities and citizens of Clark County, Wisconsin and to enhance their quality of life through endowment and grant giving."

As you will see in the "Year in Review" section of this 2016 Annual Report, we have several milestones and accomplishment to share with you. Among them, moving into new office space in December, obtaining business and liability insurance coverages, improvements to the Foundation's website, completion of successful scholarship and grant allocation cycles, selection of financial investment advisors, and the conclusion of the *Charter Donor Society* campaign on June 30th, 2016.

Each of these activities have taken a lot of planning, coordination and effort on the part of many people. The Directors, Committee Members and Volunteers have each helped guide and assist the Foundation with these accomplishments this past year. Thank you for supporting the goals of the Foundation with your time, effort, and knowledge. The Foundation succeeds because of you, and I am satisfied we are well on our way to help enhance the quality of life, here in Clark County.

#### Our Focus as we Move Forward

While we celebrate the successes of the past year, we are mindful of the future and the areas that will benefit from greater attention. Being visible and utilizing opportunities to broaden the public's awareness of the Foundation is a primary goal. This translates into making Board members available to meet with organizations and other persons interested in learning more about the Foundation – its mission and purpose. Our time at the Clark County Fair, attendance at community and local government functions and meetings, as well as other means of communication will be our focus in the coming year.

An additional priority will be finding area residents to fill the two open Board of Director positions. Once appointed, these individuals will help us connect with an even wider circle of our friends and neighbors in (or from) Clark County.

In summation, we have much to be grateful for this past year. We continue to add visible and incremental layers to the "stones" of this Foundation. With tenacious effort, these layers have been created, firmly placed, and we are confident, will stand the test of time. I continue to be impressed with the commitment and professionalism our Board and community members bring to this effort.

I am reminded of the observation our newest Board member made upon having attended their first Foundation meeting. At the conclusion of the meeting they volunteered how welcome they felt, how impressed they were with the knowledge of individual members, and the civility accorded to anyone who voiced an opposing view. A very nice compliment indeed for everyone involved with the Foundation!

I look forward to working with each of you as we continue our commitment to this worthy cause.

# CCCF ~ Year in Review

### **Executive Committee Report**

The Executive Committee meets at least once a month to take care of any business matters that need attention between Board of Director Meetings. During 2016, the Executive Committee has worked on or accomplished the following:

- established an account with Associated Trust Co.;
- received quotes and secured Directors & Officer's liability as well as General Business liability insurance coverage;
- negotiated the lease of office space within the City of Loyal Municipal Building;
- arranged for the painting and furnishing of our new office space;
- and worked with each Committee to make sure they
  had the information, support and resources that they
  needed to accomplish their goals and objectives.

### Joint Investment and Finance Committee Report

Meeting jointly, on at least a monthly basis, the Investment and Finance Committees supervise the invested assets, certain gifts, operational accounting, scholarship and grant awards, and the policies and procedures of the Foundation.

The *Investment Committee* is generally responsible for the invested assets of the Foundation. Beginning in 2015 and concluding in early 2016, committee members met with several possible investment / financial advisors on behalf of the Foundation. Ultimately, Associated Trust Company was selected by the committee as our financial managers and they were approved by the Board of Directors. On at least a monthly basis, the Investment Committee reviews the activity, holdings and performance of all invested assets.

Additionally, the Investment Committee oversees the work of the *Gift Acceptance Committee*. Certain donations (or gifts) to the Foundation require the review and acceptance by this Committee. For example, endowed Fund Agreements, real estate, objects of art, collectibles or other types of gifts would fall into this category. A new endowed scholarship fund was accepted in 2016. The *Erik Pentz Memorial Scholarship Fund* was established – in his memory – by Erik's parents Don and Judith Pentz. This Scholarship Fund benefits eligible graduating seniors

from Greenwood High School each year.

The *Finance Committee* supervises the activities of the Foundation's Treasurer and all financial reporting. At least monthly, this committee reviews current financial statements showing receipts, expenses, bank activity, investment account activity as well as gains or losses. This committee also determines that the federal, state, local or other required reports are properly and timely filed. Since they involve disbursement of funds, the activities of the *Scholarship and Grant Allocations Committees* are also supervised by the Finance Committee. (*See their reports – next page*).

#### Policies and Procedures Committee Report

The task of creating, revising and managing the Foundation's policies, procedures, forms and agreements is being accomplished by a subcommittee of the Joint Investment and Finance Committee. Meeting several times each month this group has worked on the following:

- Review / update previously approved policies, procedures or forms;
- research and draft new policies and procedures;
- Draft and / or review necessary Donor or Fund Agreements; and
- work with the Foundation's attorney, as necessary, for their review, suggested modifications, and completeness.

Once in final draft form, these items are then brought to the full Committee for their review, approval and recommendation to the full Board of Directors as necessary. The committee currently manages over 65 policies, procedures, forms, and agreements.

## **Development / Fundraising Committee Report**

The Development / Fundraising Committee is responsible for communication with the Donors, the public as well as the Foundation's promotional materials. These are highlights of the Committee's work in 2016:

- Conclusion of the Charter Donor Society campaign on June 30th, 2016,
- Initial contact with potential Donors (individuals, businesses, organizations),
- Launch of new annual fundraising (Staying Focused) campaign to support administrative costs and projects,
- Marketing materials created (revised brochure, window clings, mouse pads, business cards, letterhead, and donor remittance envelopes),
- Various press releases to print and radio outlets
- Revised CCCF website (<u>www.clarkccf.org</u>),
- On-line donations accepted from our website,
- New Twitter account (<a href="https://twitter.com/clarkccfwi">https://twitter.com/clarkccfwi</a>),
- Clark County Fair booth (August 2016),
- Open House and ribbon cutting new office 12/16,
- Presentations re: Foundation to various groups, and
- Availability to answer questions or assist other nonprofit efforts that may involve Foundation.

## Scholarship Committee Report

In 2016, the Foundation held its second *Clark County Community Scholarship* cycle and awarded \$1500 to the six students listed below. These students were selected from 41 applications received from throughout Clark County. We were pleased to see the number of scholarship applications grow from the prior year (17 in 2015). With the help of donors, we hope to provide additional, and possibly larger, individual scholarships going forward.

We are currently processing the third cycle of the *Clark County Community Scholarship*, as well as the newly created *Erik Pentz Memorial Scholarship* which

benefits Greenwood High School seniors. These scholarships will be awarded in May 2017.

#### **Grant Allocations Committee Report**

The Fall of 2016 marked the beginning of the Foundation's grant allocation program. Grant applications were accepted from October 1 through November 15, 2016 from non-profit and / or charitable organizations who were supporting or benefiting the citizens and communities of Clark County, WI. The CCCF awarded a total of \$4,700 to the six organizations listed below. Distributions came from the *Clark County Community Fund*, the *Education – Field of Interest Fund* and the *Seniors – Field of Interest Fund*.

#### 6. Bylaw Revisions Adopted since 2016 Annual Meeting - Steven W. Hemersbach, President

Article VIII, Section 8.04 of the Clark County Community Foundation, Inc. Bylaws, (as of April 21, 2016) stated that "the Vice President shall be the chairperson of the investment committee." A recommendation to revise the language of Article VIII, Section 8.04 was brought forth at the October 6 and November 3, 2016 Board of Director's meetings for consideration. This recommendation was considered, discussed and approved by unanimous vote of members present at the November 3, 2016 Board of Director's meeting. Article VIII, Section 8.04, (as revised – additions in italics below) now reads as follows:

# ARTICLE VIII - [Bylaws of the Clark County Community Foundation Inc.] COMMITTEES

#### **Section 8.04 – Investment Committee**

"The Vice President shall be the chairperson of the investment committee. The committee shall include 2 additional board members and at least 2 additional Clark County community members. While the Board of Directors has primary responsibility for the overall investment of Foundation assets, the Investment Committee is charged with the responsibility of regularly monitoring the investments. In carrying out its duties the Committee provides the Board of Directors with recommendations on investment policies and guidelines; reviews individual manager performance and recommends changes when appropriate; monitors overall investment performance, approves the selection of new managers for specific funds and works closely with staff to ensure that the investment objectives of the Corporation are being met. Committee members will discharge their duties solely in the interest of the Foundation and will exercise the care, skill, prudence and diligence that a prudent person, acting in a like capacity would use in the conduct of a similar enterprise."

"Should the Board of Directors determine that the Investment Committee function jointly with the Finance Committee, the chairperson of this joint committee shall be the Vice-President, the Treasurer, or any other agreed upon joint committee member."
